ABOUT THE SEMINAR

FEDERALISM IN INDIA: PROSPECTS & PITFALLS

The Indian federal system has become transformed in the last seven decades—from being dismissed as a full-fledged federal system to a widely acclaimed federal system in the world. Simply put, Indian federalism has become more meaningful and functional post-liberalization. It goes without saying that India's command economy, in fact, a mixed economy model has led to widespread corruption and inefficiency in the government. It has also affected Centre–state relations with the principles of federalism often being held hostage by the Centre.

From a subordinate position until the late 1980s, states rose to occupy a strategic position in India's move from a command economy to a market economy. No wonder, therefore, the Centre became more interested in involving states in even forbidden area such as foreign policy matters. States are not only competing but also learning from each other. Judiciary in India has also played some important role in curtailing the power of the central government. Judicial acceptance of federalism as basic structure of the Constitution has had significant implications on Centre–state relations in India.

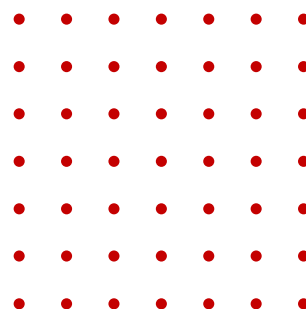


ABOUT THE SEMINAR

FEDERALISM IN INDIA: PROSPECTS & PITFALLS

The role of Governors remains an important challenge for centre-state relations in India. A major challenge for India is that of inter-regional disparities. Reducing such disparities is essential for the success of fiscal federalism. River water sharing has posed another challenge to the management of federalism. Given the spurt in discovery of offshore reserves of hydrocarbons and given the huge rents from such vast resources, which so far have remained under the preserve of the Centre, they now need to be shared. How to share these rents has become a major issue of fiscal federalism today.

Apart from resource federalism, green federalism is another big challenge for our federalism. Our existing inter-governmental transfer system does not adequately recognize environmental externalities. For example, states with large forests are seeking compensation for the environmental services they provide to the entire federation. It has long been argued that federalism creates a marketplace for public policy, in which the best policies are replicated across units. Centrally Sponsored Schemes also known as discretionary transfers, among others, have been great obstacles in laboratory federalism in India.

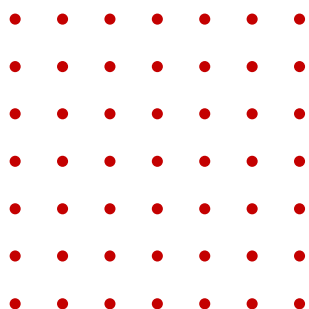
ABSTRACT SUBMISSION

RULES FOR PARTICIPATION

SUBMISSION GUIDELINES

The Paper Should Adhere the Following Guidelines :

- Format of file – Microsoft Word (Docx) or (Doc)
- Font – Times New Roman
- Font Size – 12 (Text), 10 (Footnote)
- Margins – One-inch margin on all sides
- Line spacing – 1.5 (Text), Single (Footnote)
- Citation Style: Bluebook 20th Edition
- Word Limit: Abstract: 200-250 words; Full Paper: 3000-5000 words (including footnotes and endnotes).
- Language – English only.

RULES & REGULATIONS

- Submissions will pass through blind peer review and acceptance will be subject to the report of the peer review team. Submissions not meeting the requirements mentioned will not be reviewed.
- The final paper should be submitted after the intimation of acceptance of abstract.
- The final submission shall be concluded within the prescribed deadline.
- No abstract or full paper shall be accepted after the last dates of submission, respectively.
- Paper Presenters have to register after the acceptance of abstract with payment of registration fee.
- Registration is mandatory on confirmation of the participation.

RULES & REGULATIONS

- All submissions must be original and unpublished work of the author/s and should not have been submitted, accepted or published elsewhere.
- Co-authorship of entries (maximum two) among individuals from the same or different institutions is allowed. Multiple entries by the same authors are not allowed.
- The organizing committee reserves the rights to accept and reject the submissions at any stage of the review. The decision of the organizers regarding selection of the papers shall be final.
- The copyright for all entries shall vest with the organizers who herewith reserve the right to modify the contributions as per the requirements of necessity
- There shall be a Zero tolerance policy on Plagiarism and Copyright. Similarity up to 15% is permissible.

- All the final submissions shall be subjected to blind peer review and plagiarism check, subsequent to which the selected papers will be considered.
- Certificate will be awarded to the registered participants who will attend the full Seminar.

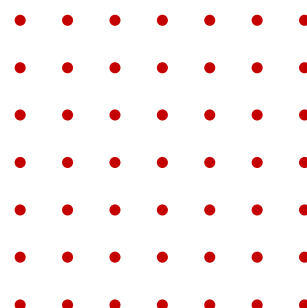

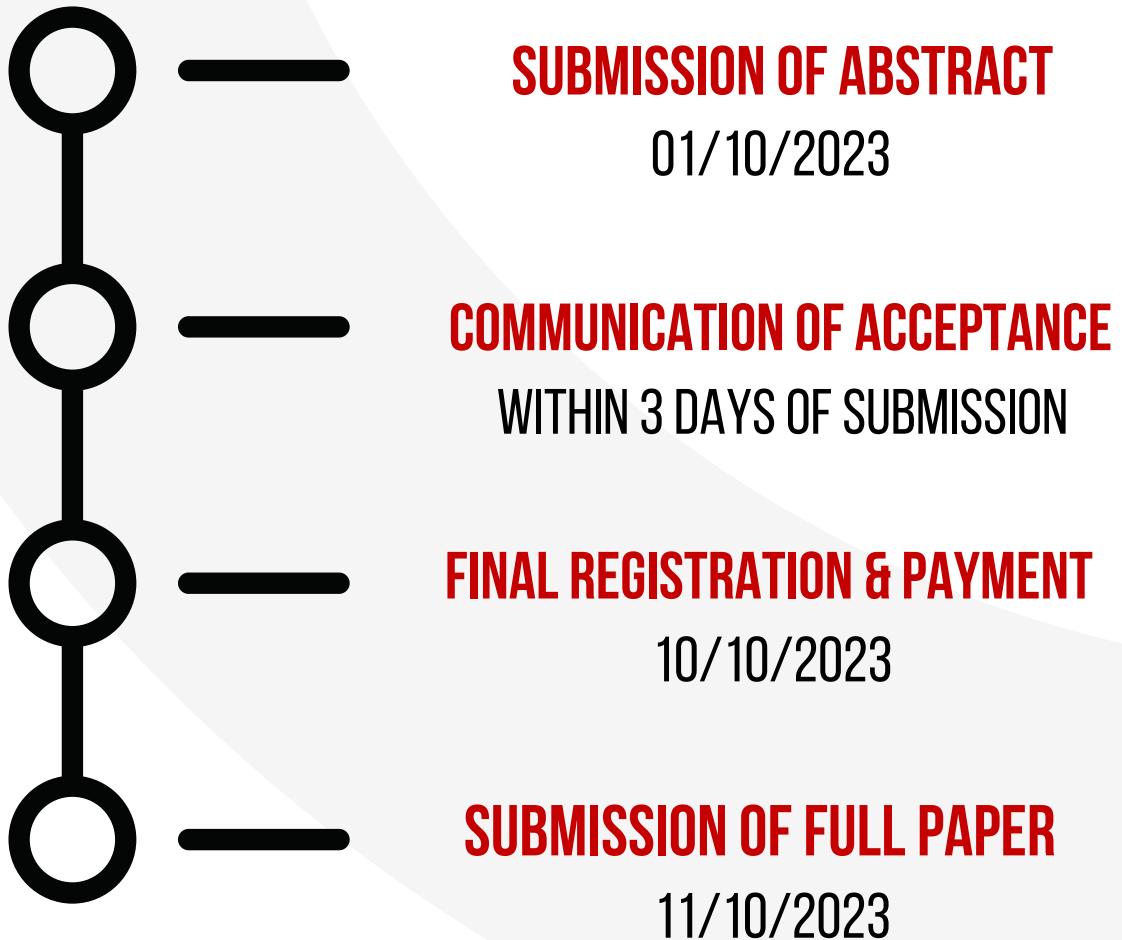
